The idea of having a Political Certification is not a new idea in that there has been several goals for people to pledge to an idea or a constitution, additionally many professional organizations have the notion of a certification.

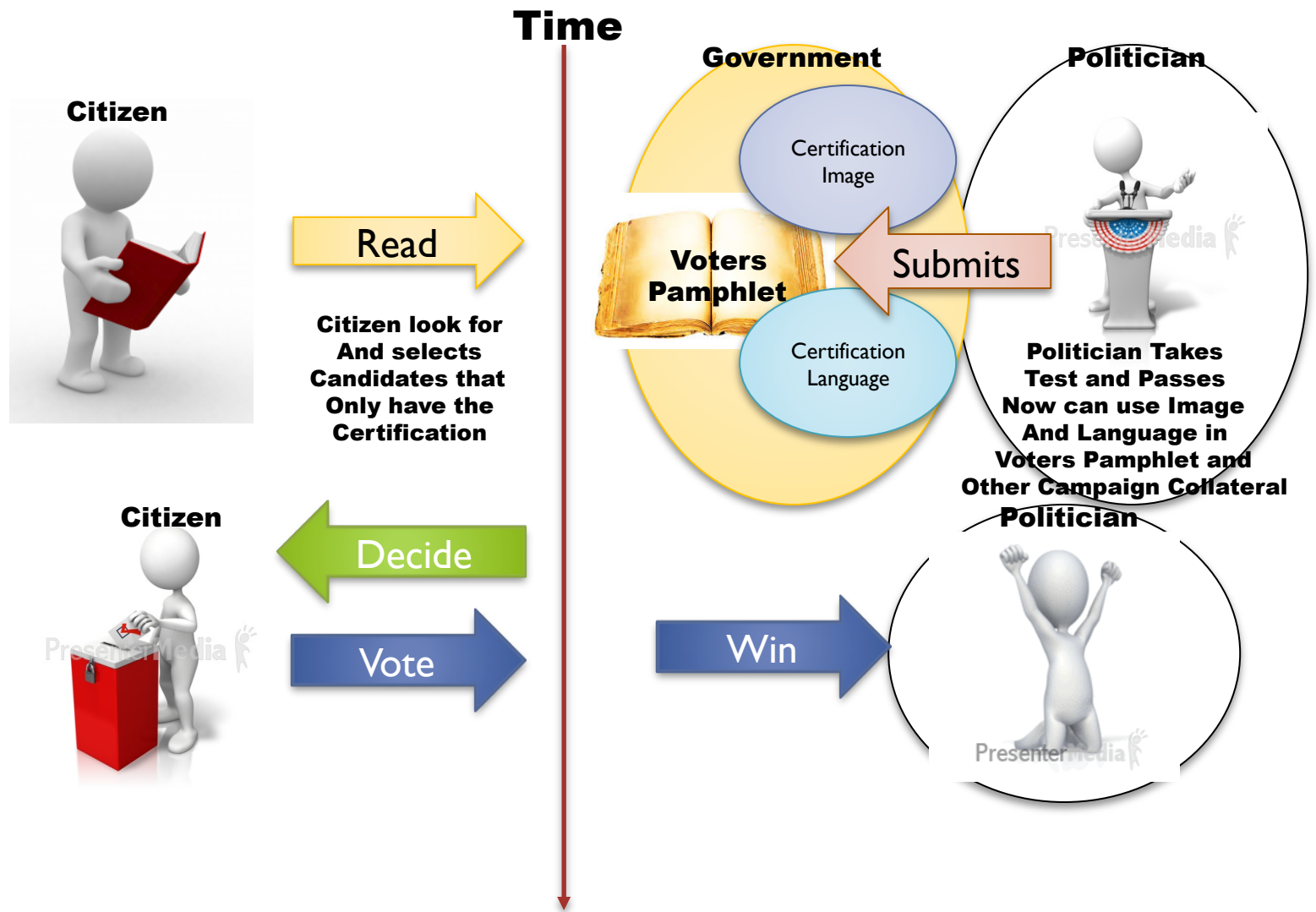

This approach, en-mass would drive a society to a given philosophy that would benefit the widest group of people indefinitely.

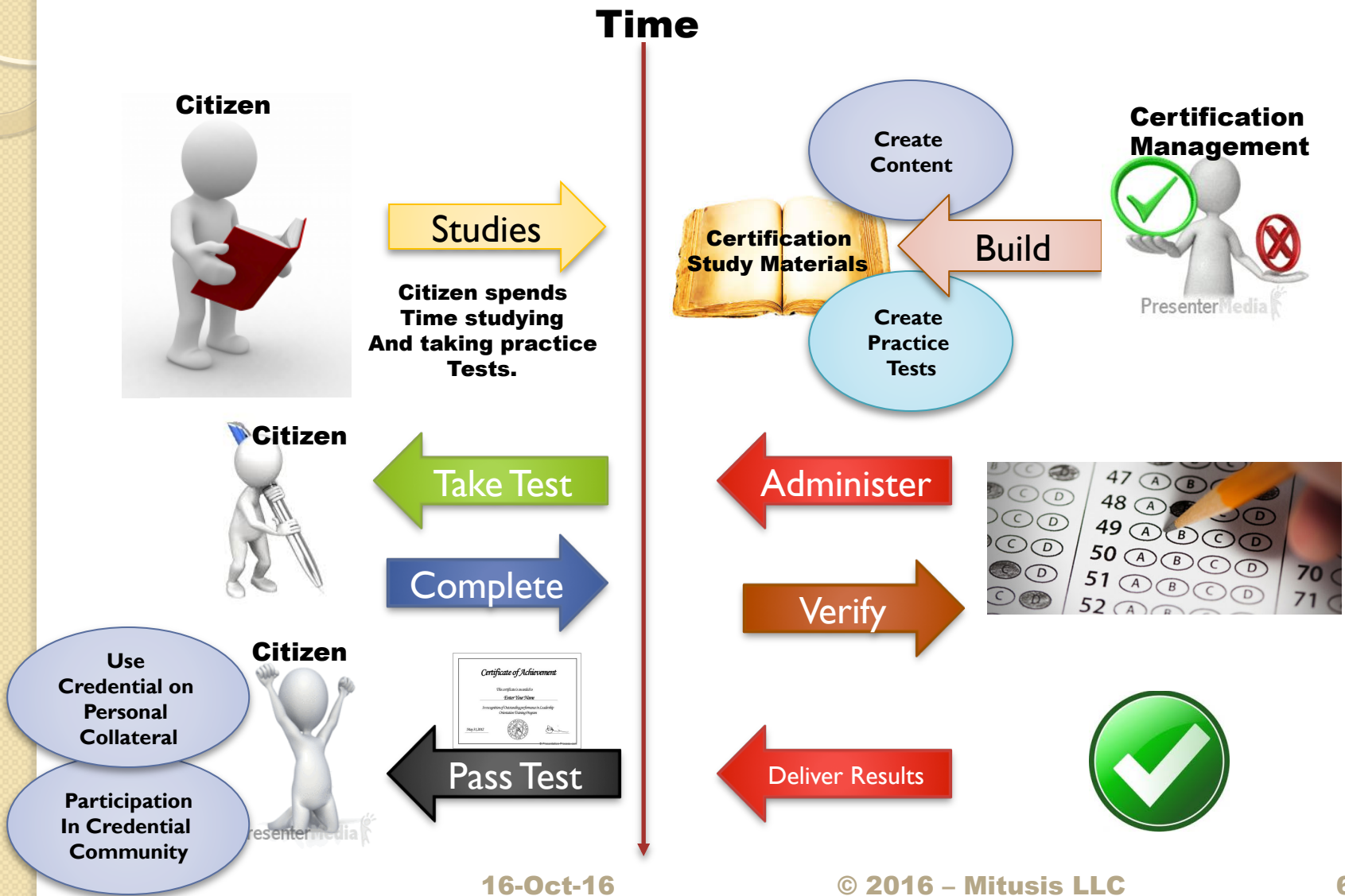
Citizen Experience Use Cases

- Citizen Reviews Candidates and Votes
 - Review the Voting Pamphlet
 - Votes for those candidates that have the desired certification listed and Successfully Submits Ballot
- Citizen Obtains the Certification
 - Study the Materials / Take Class

Citizen Takes Certification

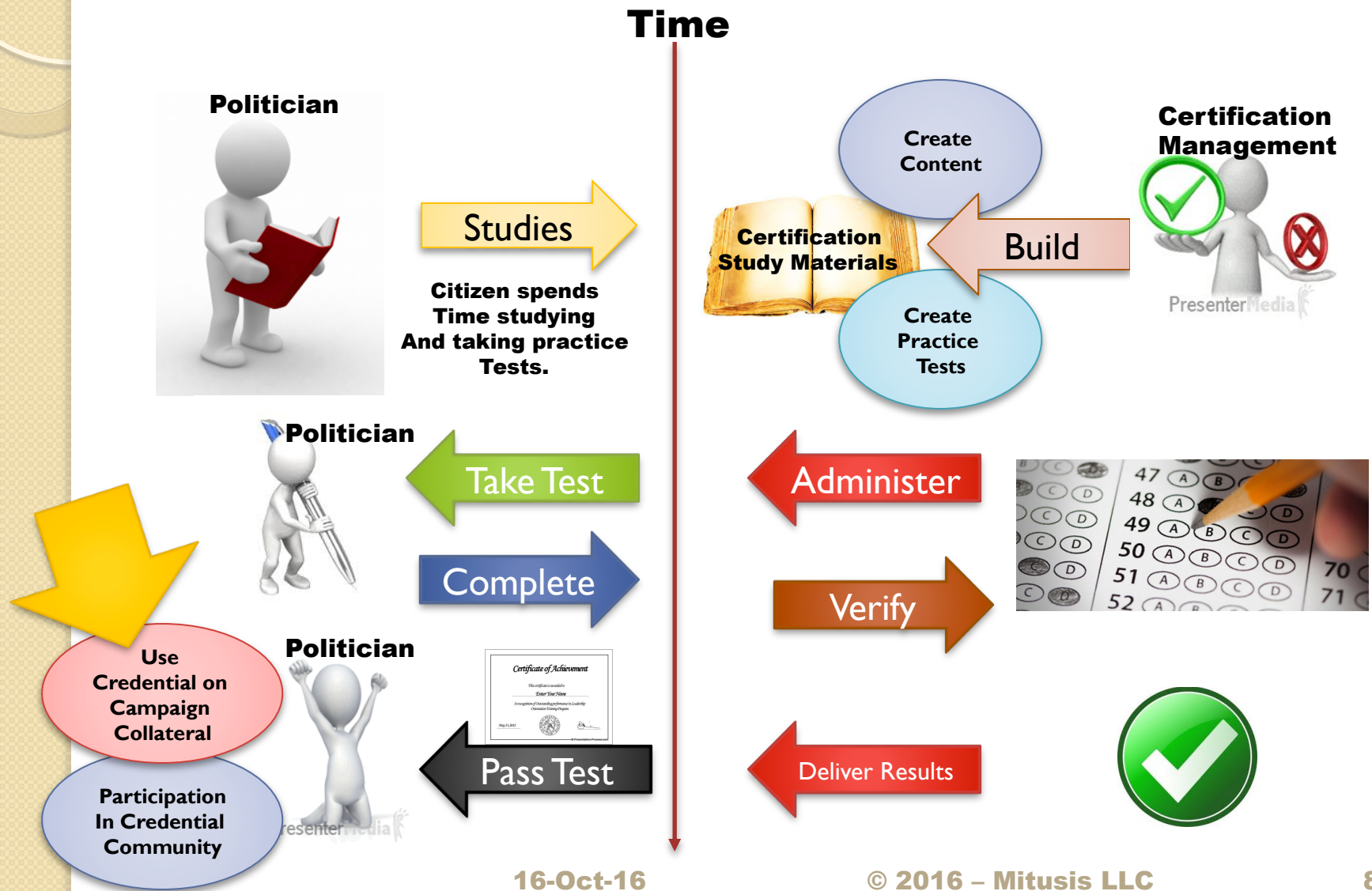




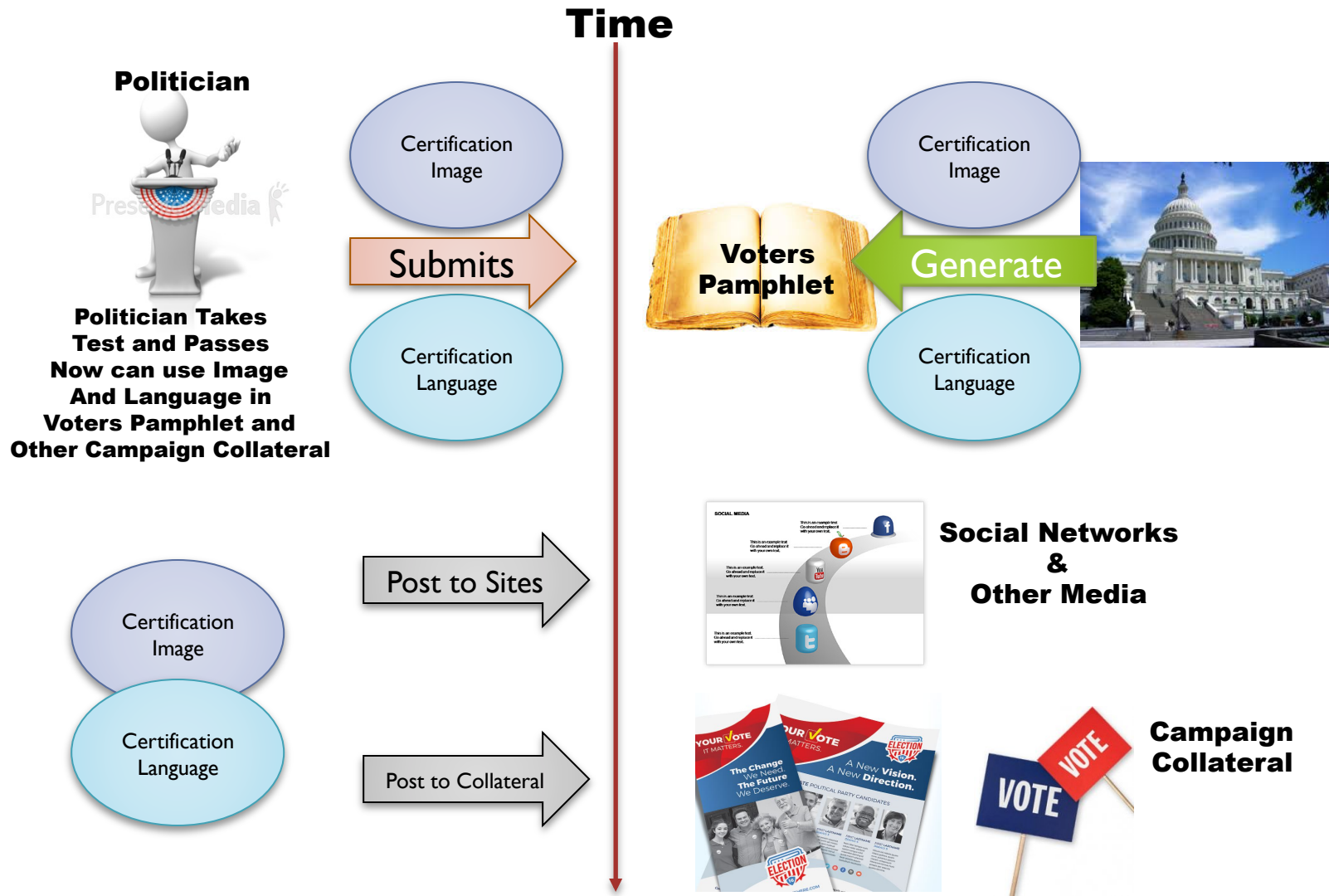
Politician Experience Use Case

- **Politician Obtains the Certification**
 - Study the Materials / Take Class
 - Sit for the Test
 - Receive pass/fail notification
 - If pass, receive the certificate paper
 - Allows recipient to post to personal sites and to their own tag lines and can be used in their Campaign
- **Politician Uses Certificate**
 - Politician Submits their Paper work for their position with Certificate added as text or image
 - Allows the Politician to post to personal sites and to their own tag lines
 - Allows the Politician to post to all Campaign collateral
- **Politician Uses Micro-Funding and Interaction Website**
 - Politician Uses the Certificate Communications Website
 - Utilized for Communicating to Constituents
 - Utilized for Micro-Funding for support

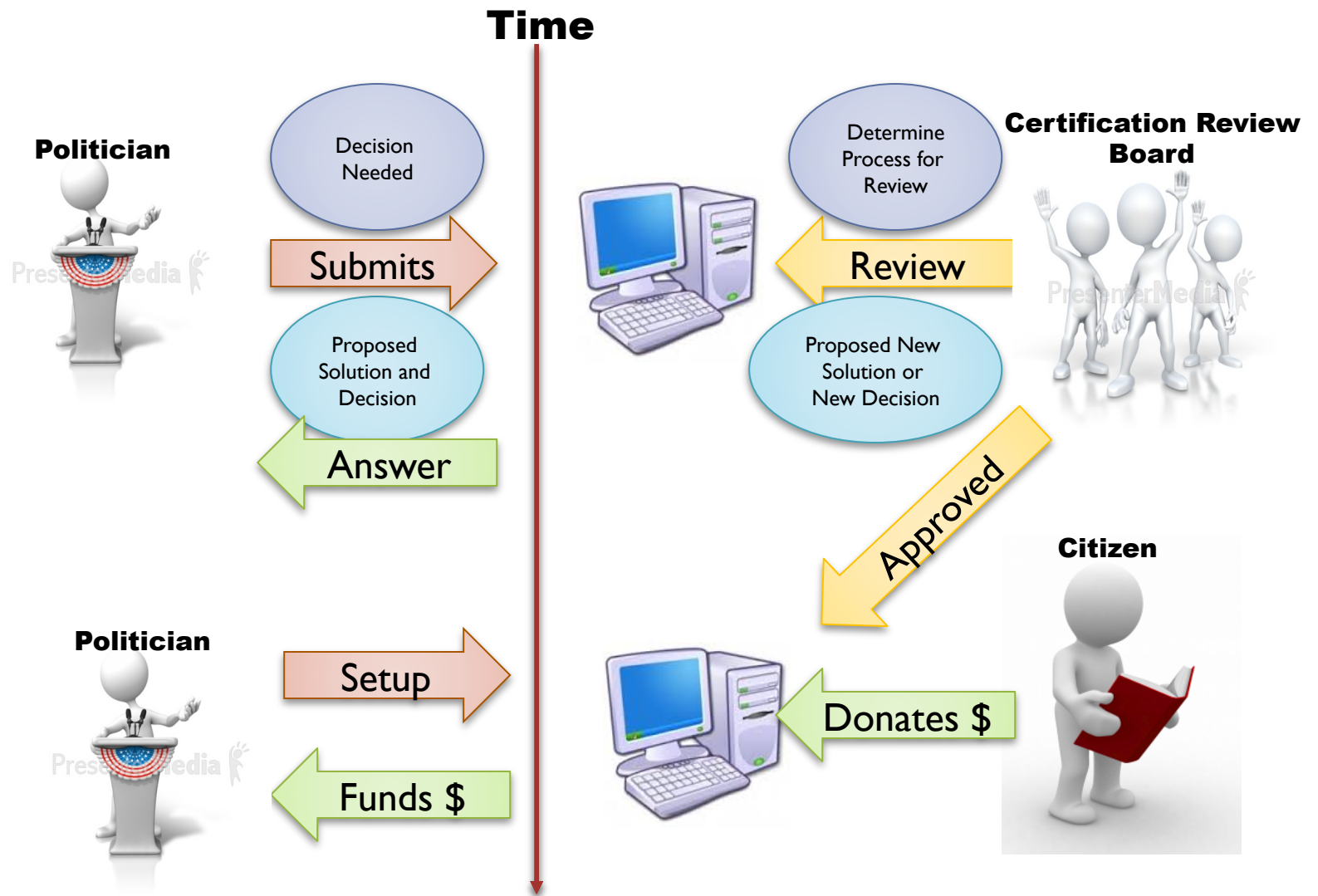
Politician Takes Certification

Politician Utilizes Certificate Website

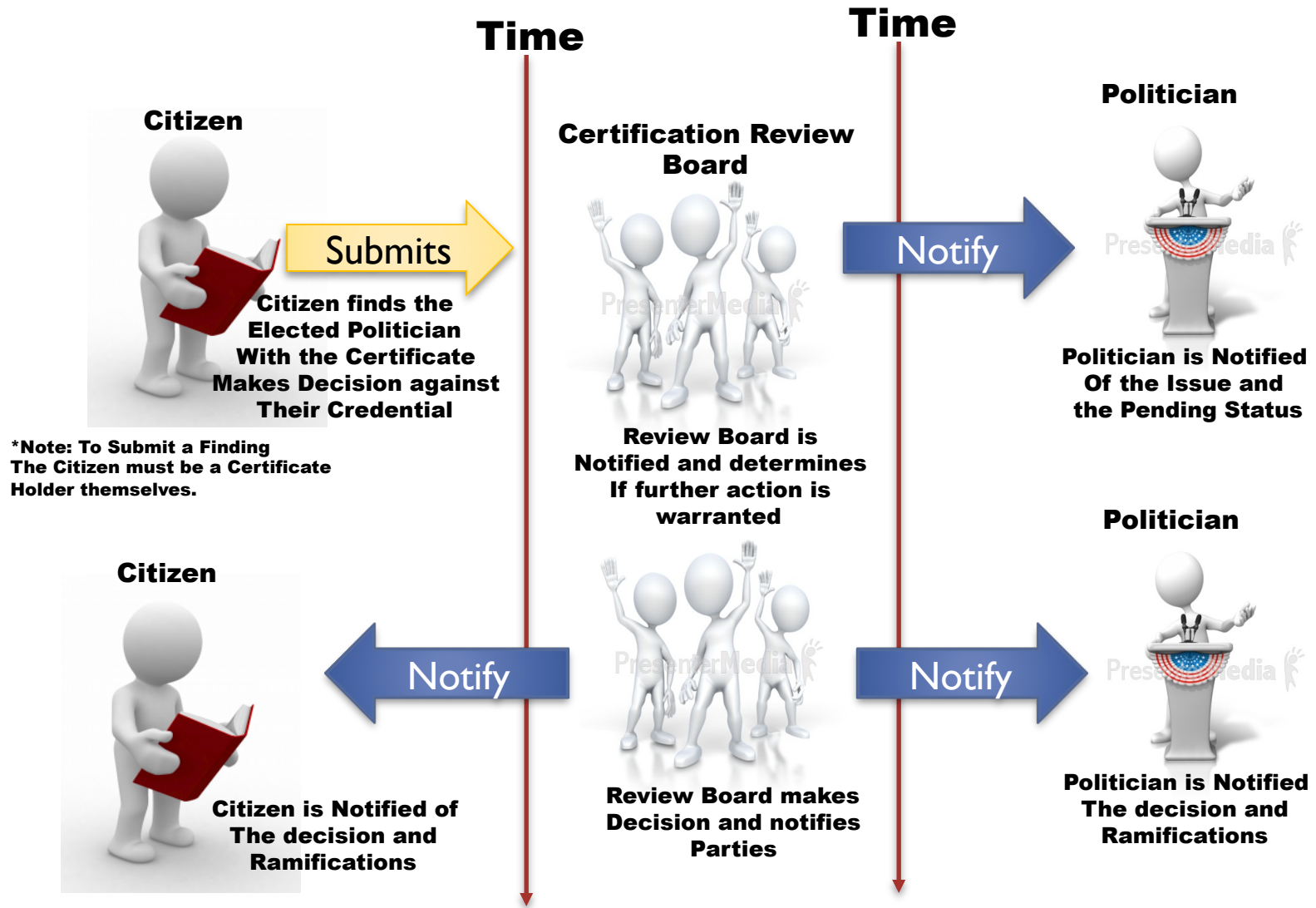




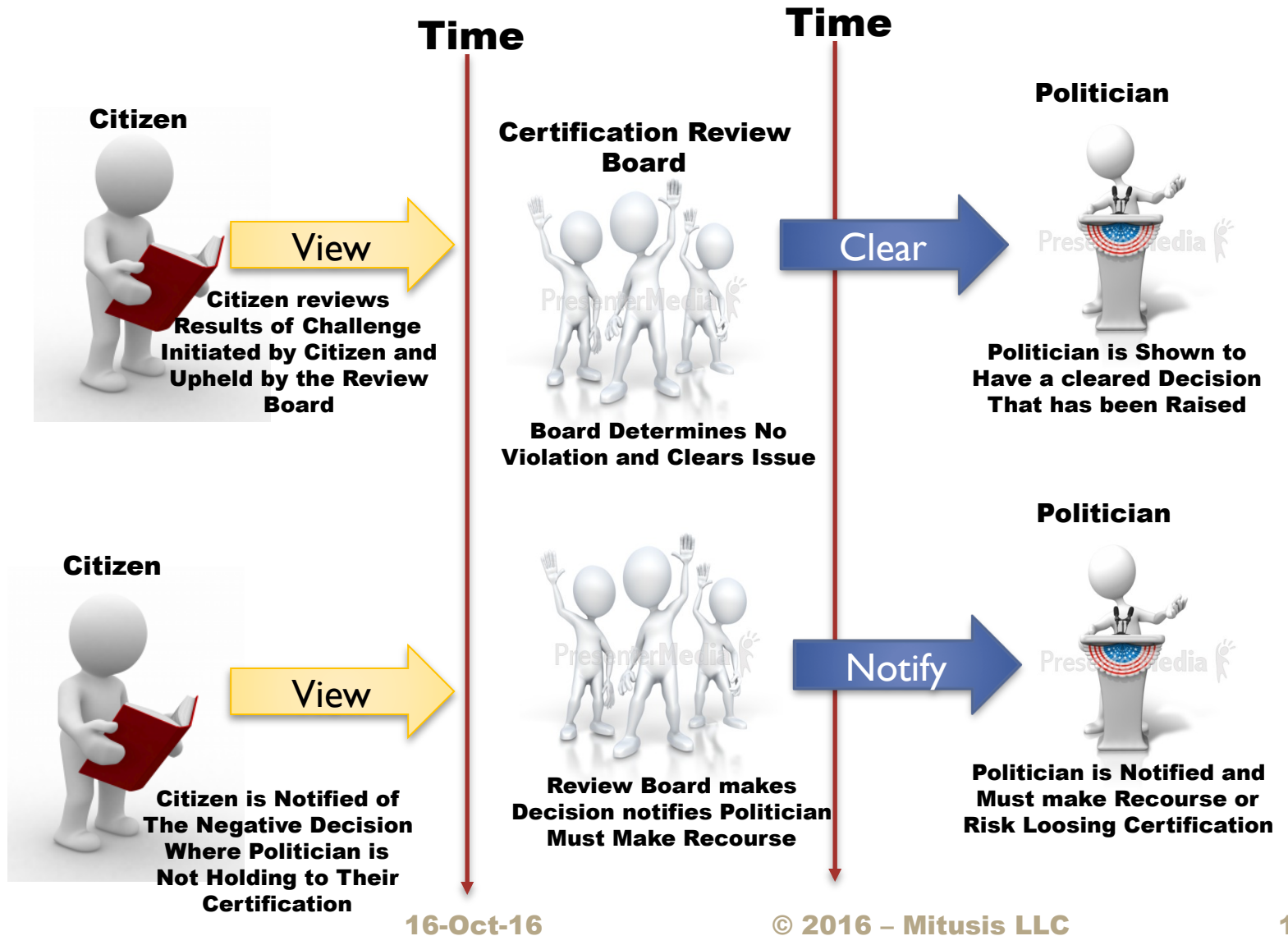
Citizen Recourse Use Cases

- Politician, as a representative of the Citizen, makes a decision that is against the principles of the Certificate
 - Citizen that holds the Certification documents the incident and submits to the Certification Board for Review
 - Representative is notified of the report and proposed decision date for further action
 - Decision is made the the parties are notified of the decision.
- Citizen looks up decision and reviews
 - Citizen looks up the proposed decision and reasons for decision and how they align with the Certification
- Citizen Supports Politician Financially and Follows
 - Citizen joins a highly secure website that allows Micro Payments and allows the Citizen to follow and participate in the efforts of the Politician.

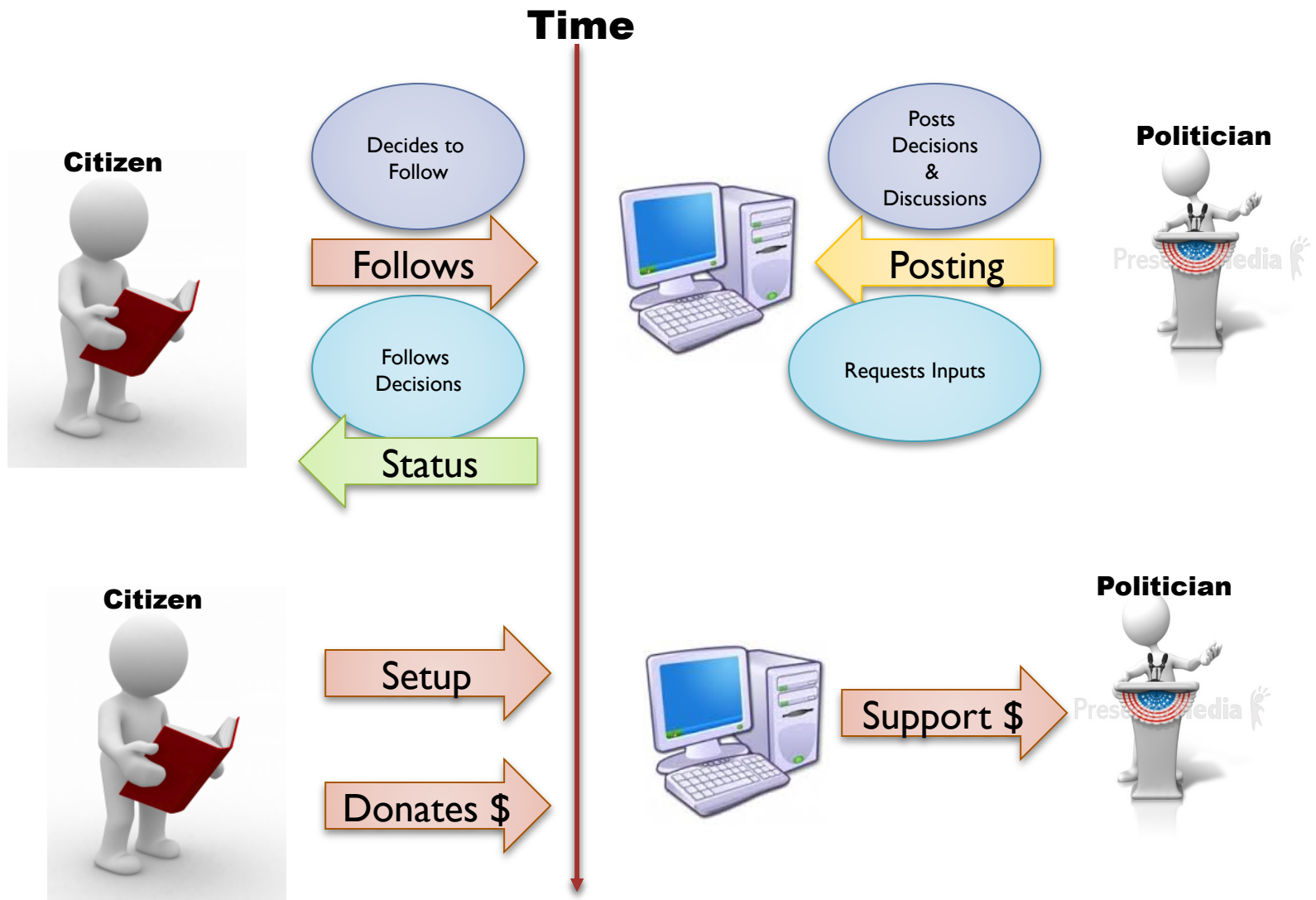
Citizen Recourse against Decision I

Political Certification Recourse

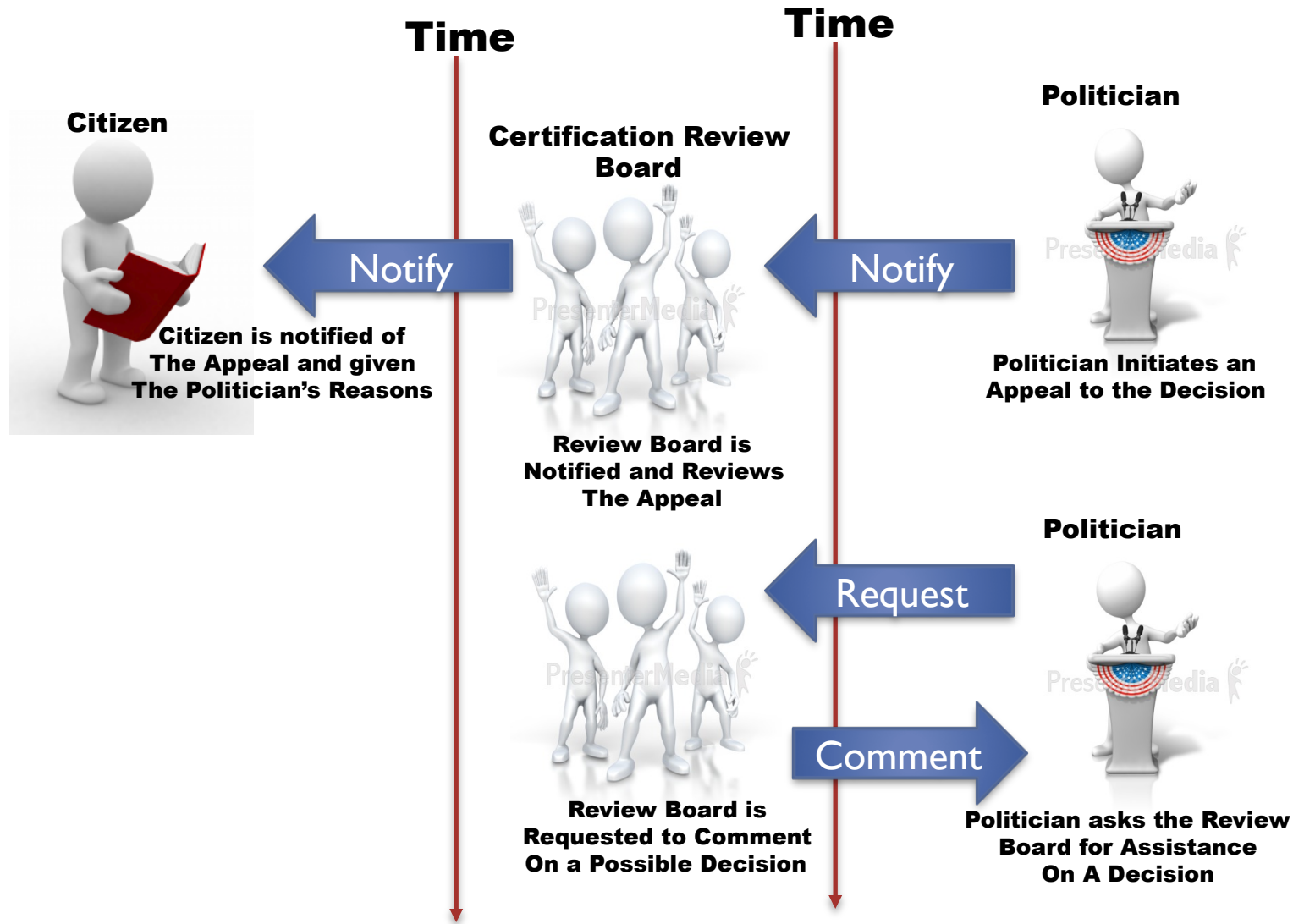
- If Politician is found to have Violated their Oath and Certification the following shall happen:
 - Politician is expected to make recourse within 3 months of Decision.
 - If Recourse is not applied in the 3 months, their Certification is considered to be Suspended, the Politician will have another 3 months in which time their Certification will be Revoked.
 - Politician can retake the Certification Course within 12 months and be re-instated.
 - One additional Violation and the Certification is permanently Removed and the Politician Cannot received it again.
 - If Politician Violates a second Decision within the initial 12 months of the first Violation, the Politician will have their Certification permanently revoked and efforts for impeachment should proceed.



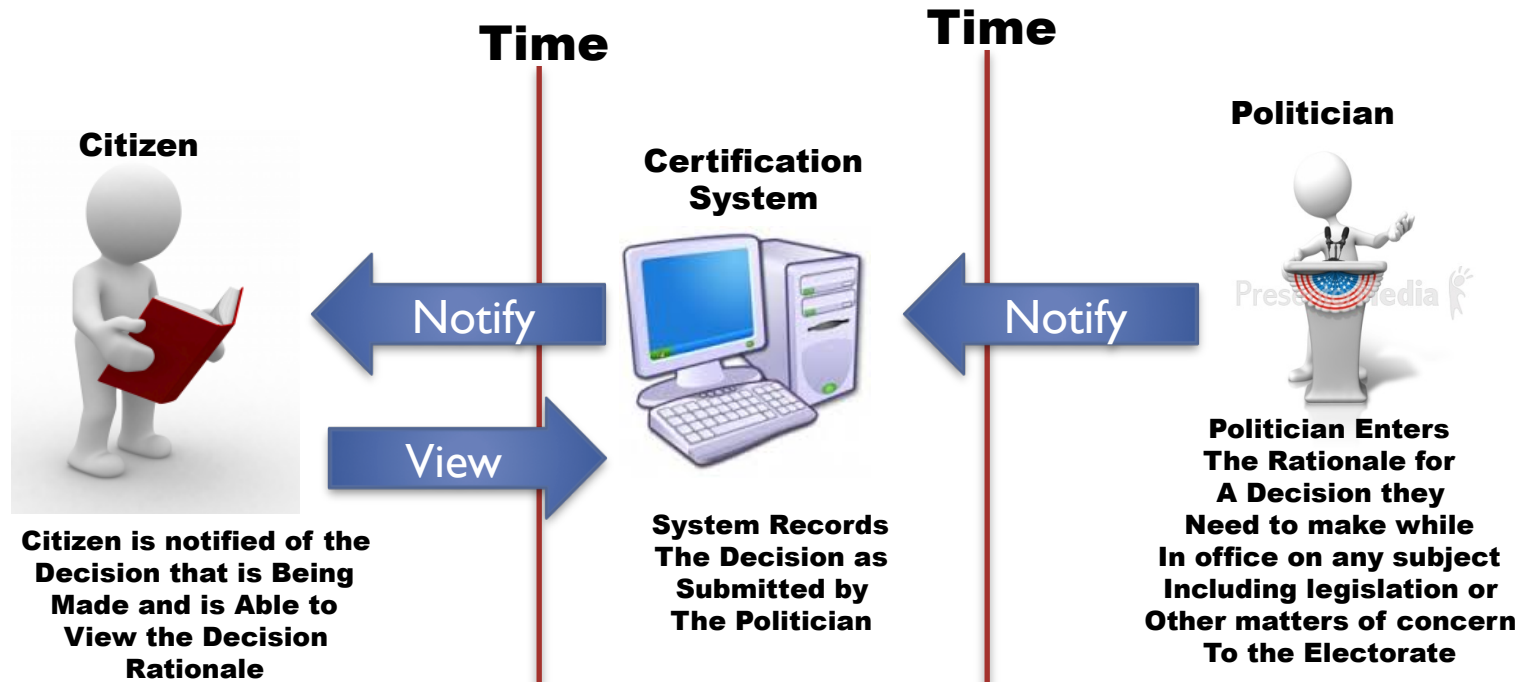
Politician Recourse Use Cases

- **Politician Initiates Appeal**
 - Politician is provided the opportunity to defend the decision and how it supports the intent of the Certification and what it represents
- **Politician Submits for Decision Assistance**
 - Politician is not clear as to what decision would best align with their Certification.
 - Politician receives response
 - Politician votes in alignment of response
- **Politician Submits Decisions in Alignment**
 - Politician submits their decisions and how they align with the Certification

Politician Recourse on Decision I



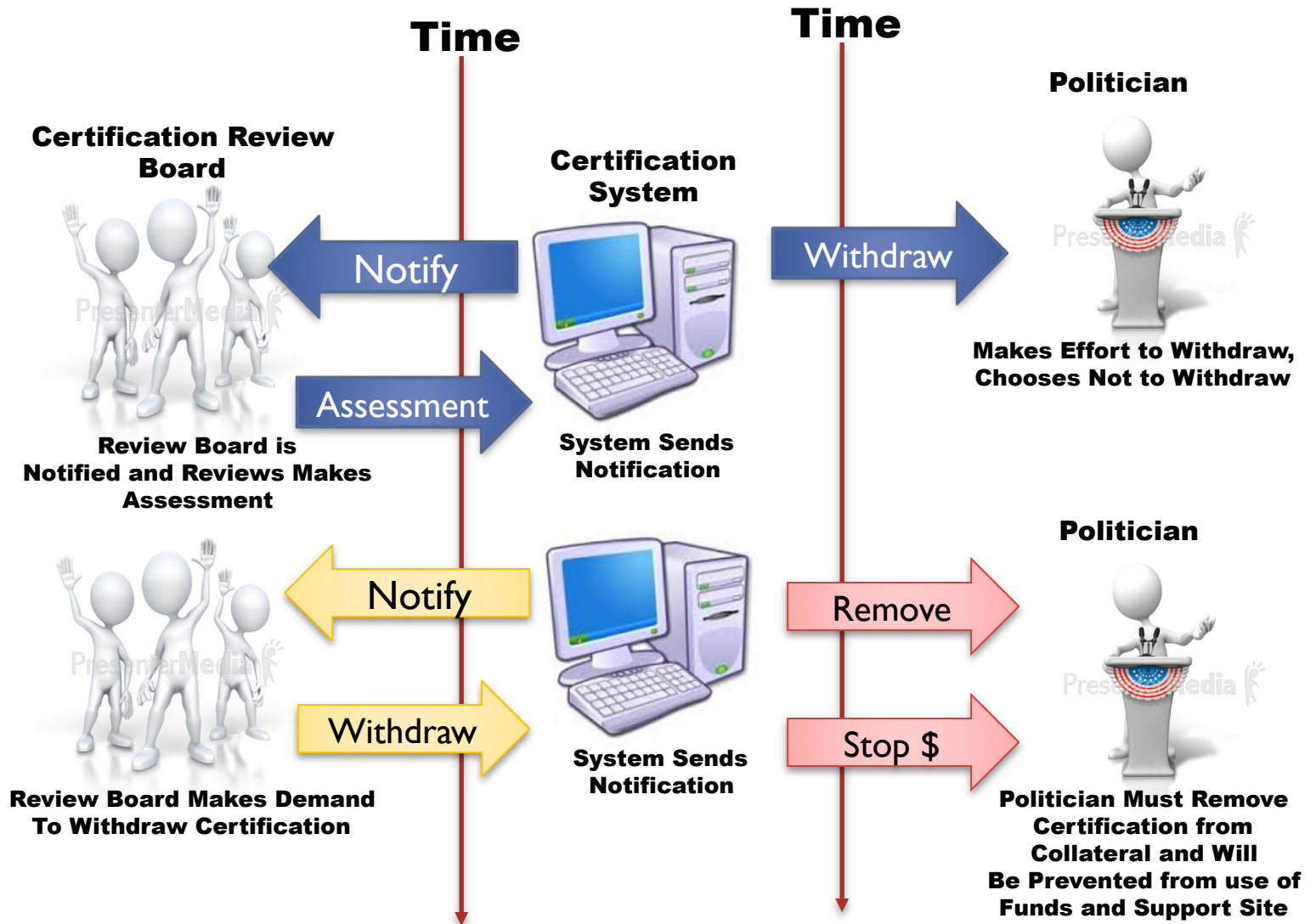
Politician Recourse on Decision II



Certificate Board Use Cases

- Reported Violation Decision is that Certificate has been violated
 - Reported Violation
 - Assessment Initiated
 - Process is taken to “withdrawn” Decision
 - Certificate is “withdrawn” from Politician
 - All Collateral must be scrubbed of Certificate
 - Violation with Withdrawal of Funds and Support
- Certificate Board Oversees Certification Process
 - Manages Process for Content
 - Manages Process for Approved Educational Vendors
 - Manages Process for Certification Tests

Certificate Board Decides on Violation

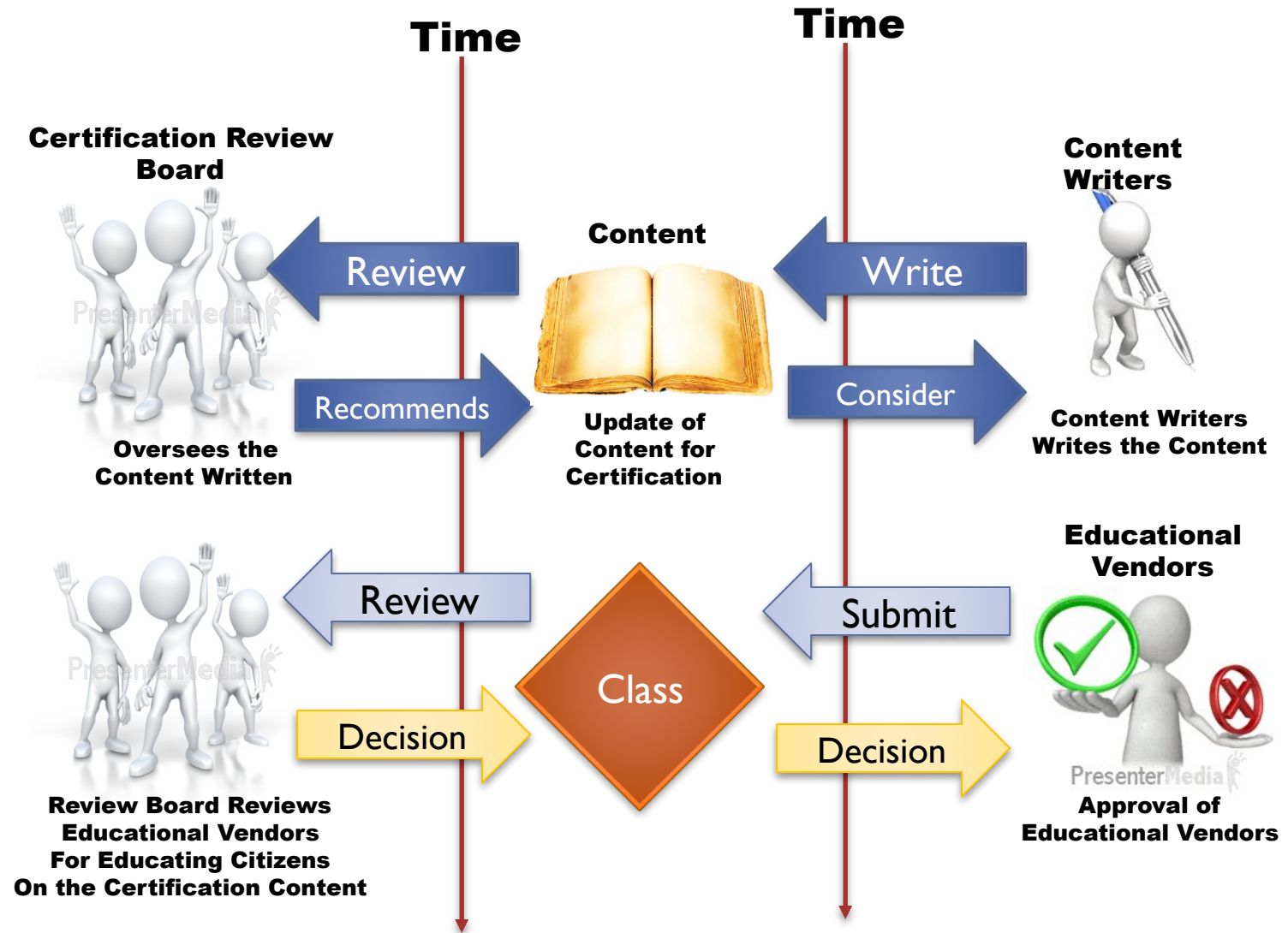

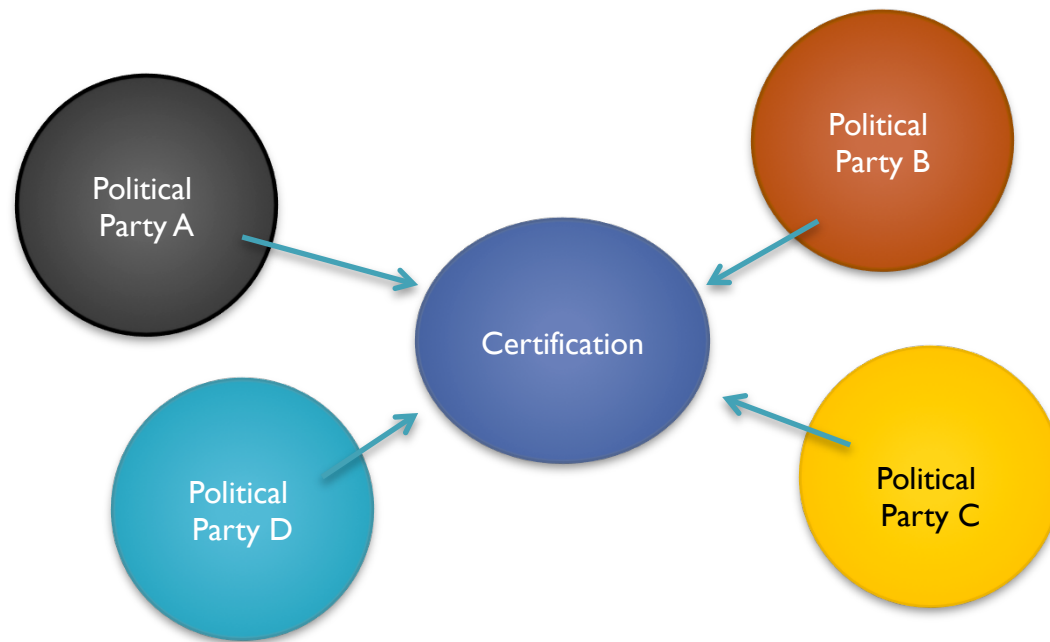
Certification Approach I

- Open Source Approach
 - The certification will take an open source approach in that, the initial certification process will handle all potential candidates with no alignment to any political party.
 - The Certification will only handle specific basic concepts for governing.
 - The Candidates will fill in the remaining issues that are important to the citizens.



Certification Approach II

- Open Source Approach
 - Any Political Party can Adopt the Certification as long as they pass the Certification and they do not violate the intention of the Certification.





Open Source Approach

- The certification will take an open source approach in that, the initial certification process will handle all potential candidates with no alignment to any political party.
- The Certification will only handle specific basic concepts for governing.
- The Candidates will fill in the remaining issues that are important to the citizens.
- Where there are areas that are not addressed by the Certification, the Politician is free to describe or define their position.
 - The Certification will also consider Intent, so changing the name of something does not mean the intent of the legislation is different. The Board will determine intent relative to the intent of the Certification and make the decision.
 - Politicians that take and pass the Certification are expected to know and understand Intent and not play with words to circumvent the intent of the Certification process and approach.

Phases (Part I)

- There will be three phases to start...
- Phase I – Initial Paper Test with following tools:
 - High Level Unified Assessment – 4 Questions
 - Assess the individual in their perception of the overall Unified Theory Political Map. (Free)
 - Detailed Level Unified Assessment – 40 Questions
 - Assess the individual in more detail to determine if their perceptions are correct from the first test.
 - Certification Test – 200 Questions
 - Focused on the Unified Theory and the Political Rules.
 - Administered by Hand at a cost of \$50 per sitting.

Phases (Part II)

- Phase II – Second Generation Paper Test with following tools:
 - High Level Unified Assessment – 4 Questions
 - Assess the individual in their perception of the overall Unified Theory Political Map.
 - Detailed Level Unified Assessment – 40 Questions
 - Assess the individual in more detail to determine if their perceptions are correct from the first test.
 - Certification Test – 400 Questions
 - 200 Questions - Focused on the Unified Theory and the Political Rules.
 - 200 Questions – Focused on the Constitutional Requirements
 - Cost for Certification Test would be \$200
 - Administered by hand.

Phases (Part III)

- Phase III – Third Generation Computer Test with following tools:
 - High Level Unified Assessment – 4 Questions
 - Assess the individual in their perception of the overall Unified Theory Political Map.
 - Detailed Level Unified Assessment – 40 Questions
 - Assess the individual in more detail to determine if their perceptions are correct from the first test.
 - Certification Test – 400 Questions
 - 100 Questions - Focused on the Unified Theory and the Political Rules.
 - 300 Questions – Focused on the Constitutional Requirements
 - Cost for Certification Test would be \$400
 - Administered by hand.



Emotions / Logic / Vices

- Emotions – Are the day to day feelings that any one individual has at any one moment, they include the concept of happiness, sadness, disgust, anger, fear, indifference, etc.
- Logic – This is when an individual uses the notion of deductive or inductive logic. The ability to identify items based on their characteristics as a whole, then to be able to deduce a thing belongs to a given group based on those characteristics.
- Vices – Are the behaviors an individual that indulges in that either damage their own body or the moral fabric of their life in the community or within their family, where the individual is not able to stop the destructive behaviors on their own.
