# Political Challenges (Part I)

- **Current Model focuses on Money (Money)**
  - Needed to Wash Candidates Away
    - Attack Ads and other Methods to Depress Votes
  - Needed to Elevate the Chosen
    - Engagement with Donors and Media with Approval
- **Political Class Control (Class Control)**
  - Hands of Government Regulation
    - Controlling Economy to Assist Constituents
  - Hands of Morally Defined Success
    - The Initiatives are defined as Morally Superior
- **No Direction Other than Winning (Win at all Cost)**
  - Voter Drives focused on New Voters
    - System to discover and recruit Liberal Voters
  - Embracing unbridled immigration
    - Most unvetted immigrants are most likely to vote Democate



# Political Challenges (Part II)

- **Current Model Driving to Socialism (Socialism)**
  - **Obamacare**
    - Next steps are to push for Government Program
  - **Economic Controls with “Carbon Tax”**
    - Next steps is to gauge business through global warming
- **Judicial System Political Focus (Judicial Justice)**
  - **“Lives Matter” Mantra**
    - Next steps to legitimize violence if policy not “right”
  - **Vetting of Immigrants**
    - Next steps to allow free flow
- **Focus on Creating Government Need (Dependency)**
  - **Health Care Chaos**
  - **Policing Chaos**
  - **Economic Chaos**
- **More Government Oversight Needed to Fix It!!!!**



# Naming Problems (Part I)

- The first step to solving a problem is to name the problem.
  - In this case, we have a problem with Philosophy as a Nation. The real question is:
    - Should we allow Government to solve all of these challenges?
- What are the strategic problems?
  - One of the strategies of establishing and maintaining Chaos is to prevent another Philosophy to take hold.
  - One of the strategies is to keep the population that does not support Government efforts impugned and demoralized.
  - One of the strategies is to take control of Media through the news cycle and through the use of shows and movies to push for a philosophy that requires Government.
- What would happen if we could devise a strategy that could dismantle these approaches?



# Naming Problem (Part II)

- It is impossible to label a Philosophy that changes and adjusts:
  - To keep the their own in power and to grow that power.
- Any attempts to label the mass of people engaged in this behavior turns out to meaningless.
  - The words and actions are not singular and not attached to any book or direction.
- What would happen if we could label some thing that was opposing.
  - Something that would have similar characteristics but would eliminate the most dangerous aspects of the current march of Philosophy.
- Is it possible to go about this such that we could achieve some sense of sanity and beat back the drive to bigger more controlling government?
  - What could we do to engage the other 50% that don't vote?



# Finding Solutions (Part I)

- How do we constrain this Problem?
  - What Questions Should be Asked?
  - As an individual, on a day to day life we suffer from the following realities/constraints in society:
    - Daily Risks to Living
    - Natural Laws that we cannot control
    - Liberty in our social interactions with others
    - Markets where we exchange our labor for goods and services
    - Are there other realities/constraints?
- It would stand to reason than to find a solution we should the answer the following questions:
  - Are Daily Risks Controllable by Government?
  - Are Natural Laws Defined by Government?
  - Is Liberty Defined by Government?
  - Should the Market Place be Controlled by Government?



# Finding Solutions (Part II)

- Dimensions of Success for a Society
  - Daily Risks
    - Government has the Ability to Control
    - Government does not have Ability to Control
  - Natural Laws
    - Defined by Objective Perspectives
    - Defined by Theological Perspectives
  - Markets
    - Need to be Controlled
    - Need to be Liberated
  - Liberty
    - Defined by what is Permitted by Government
    - Defined by what is Possible by Limited Government

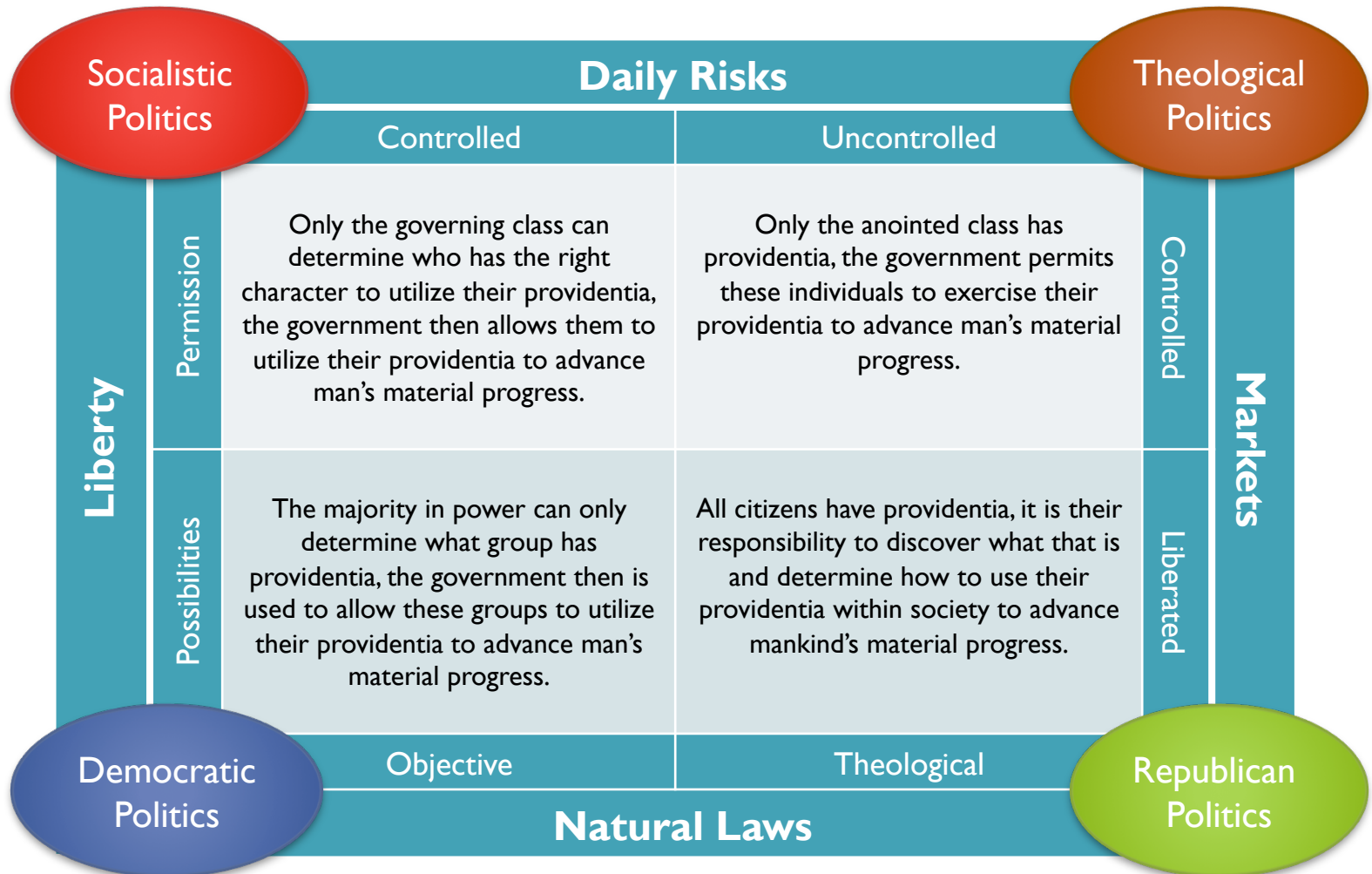

# Finding Solutions (V)

- These Dimensions should help shape a society to best develop the following:
  - The Creation of Spirit:
    - Liberty = Permitted; The Justification to Impose a Standard to Manage Happiness: While believing the government is required to ensure the human spirit is fulfilled, regulations and judicial social justice processes are implemented to provide fulfillment to those whom side with the government while negatively impacting others whom may not be in favor.
    - Liberty = Possibilities; The Reverence for Individual Determination to Manage Happiness: While believing that one has the ability to manage their own happiness, there is always the possibility that society will not agree with the efforts. While risks are a part of living life there is also that ability to learn from failed attempts as well as reap the rewards of success through supporting regulations and judicial processes.
  - Providentia (Ability):
    - The ability to see something in advance; foresight, foreknowledge. Precaution, providence, forethought.
  - Provideo (Action):
    - I foresee. I am cautious; I act with foresight. I provide, see to. I look after, care for
- Internal Perspective: Belief/Skills to Achieve Results
  - Daily Risks – Government Use of Regulations
  - Natural Laws – Government Use of the Judicial System

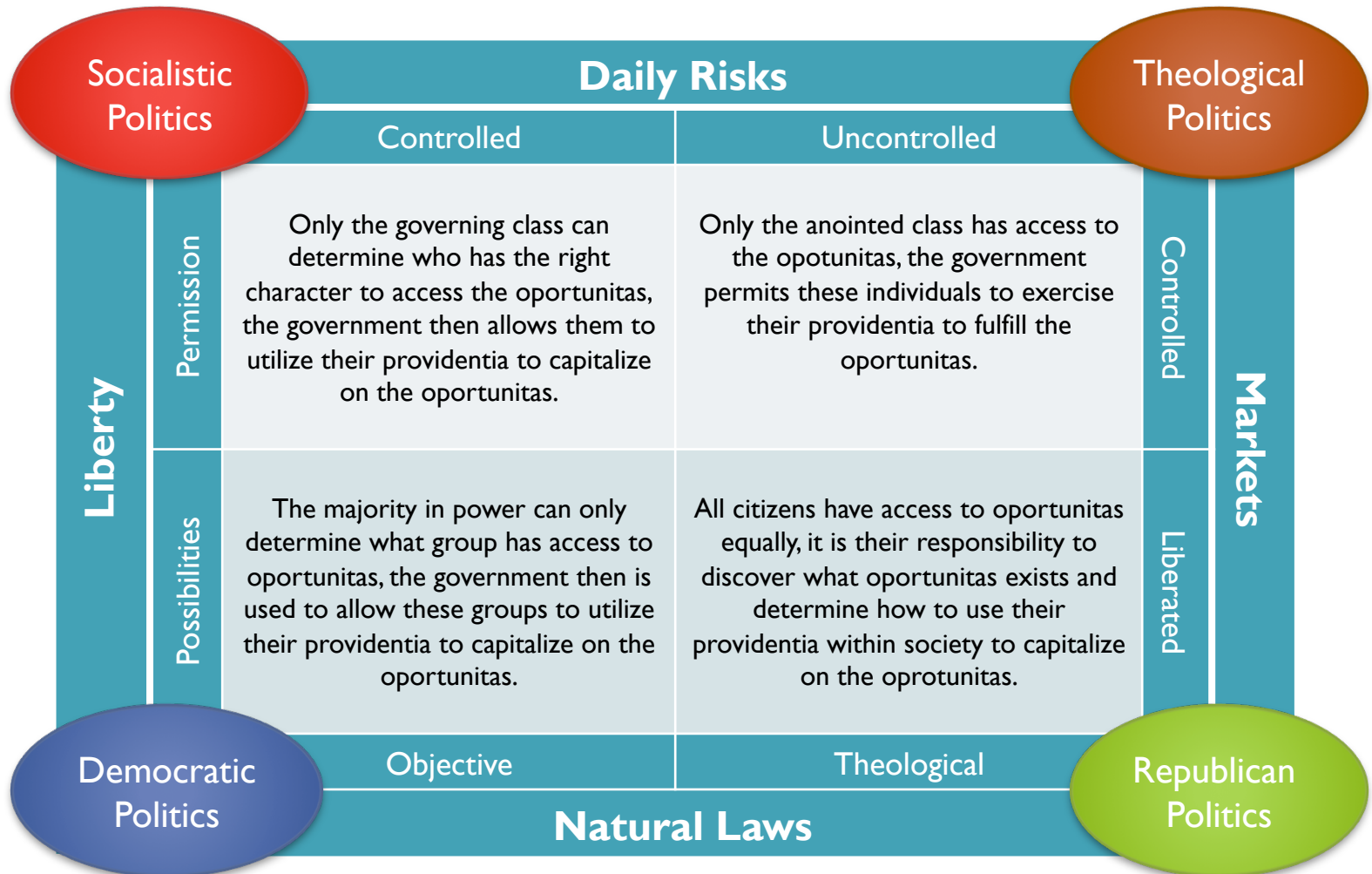


# Finding Solutions (VII)

- These Dimensions should help shape a society to best develop the following:
  - The Creation of Wealth:
    - Markets = Controlled: The Justification to Control Oportunitas: Determination that the overall material progress of the nation should be implemented by a given group, such that the resources to grow an individual's oportunitas (Resources and Tools) would be determined by the government and provided to the individual based on their commitment to the ideology. Where man's material progress is determined by the use of available resources plus the human energy times tools.  $MMP = R + (HE * T)$
    - Markets = Liberated: The Justification to Liberate Oportunitas: Determination that the overall material progress of the nation should be liberated to be decided by the citizens, such that the means to grow an individual's oportunitas (Resources and Tools) would be determined by the individual and provided to the individual based on their individual initiative. Where man's material progress is determined by the use of available resources plus the human energy times tools.  $MMP = R + (HE * T)$
  - Oportunitas (Ability):
    - Convenience, fitness, advantage, opportunity.
  - Proficio (Action):
    - I advance, make progress. I benefit, profit. I help, contribute, am useful.
- External Perspective: Mechanisms to Achieve Results
  - Management of Markets – Government Use of Legislation
  - Liberty – Government Use of the Constitution

# Finding Solutions (IX)

- The approach that will provide the best avenue to prosperity and ability for deviant behavior to be reduced or eliminated:
  - Through Providentia: All citizens have providentia, it is their responsibility to discover what that is and determine how to use their providentia within society to advance mankind's material progress.
  - Through Oportunitas: All citizens have access to oportunitas equally, it is their responsibility to discover what oportunitas exists and determine how to use their providentia within society to capitalize on the oportunitas.
- This perspective will have a positive impact on reducing the probability of individuals engaging in Lying, Cheating or Stealing to survive and live their life fully, with the end result being happiness.

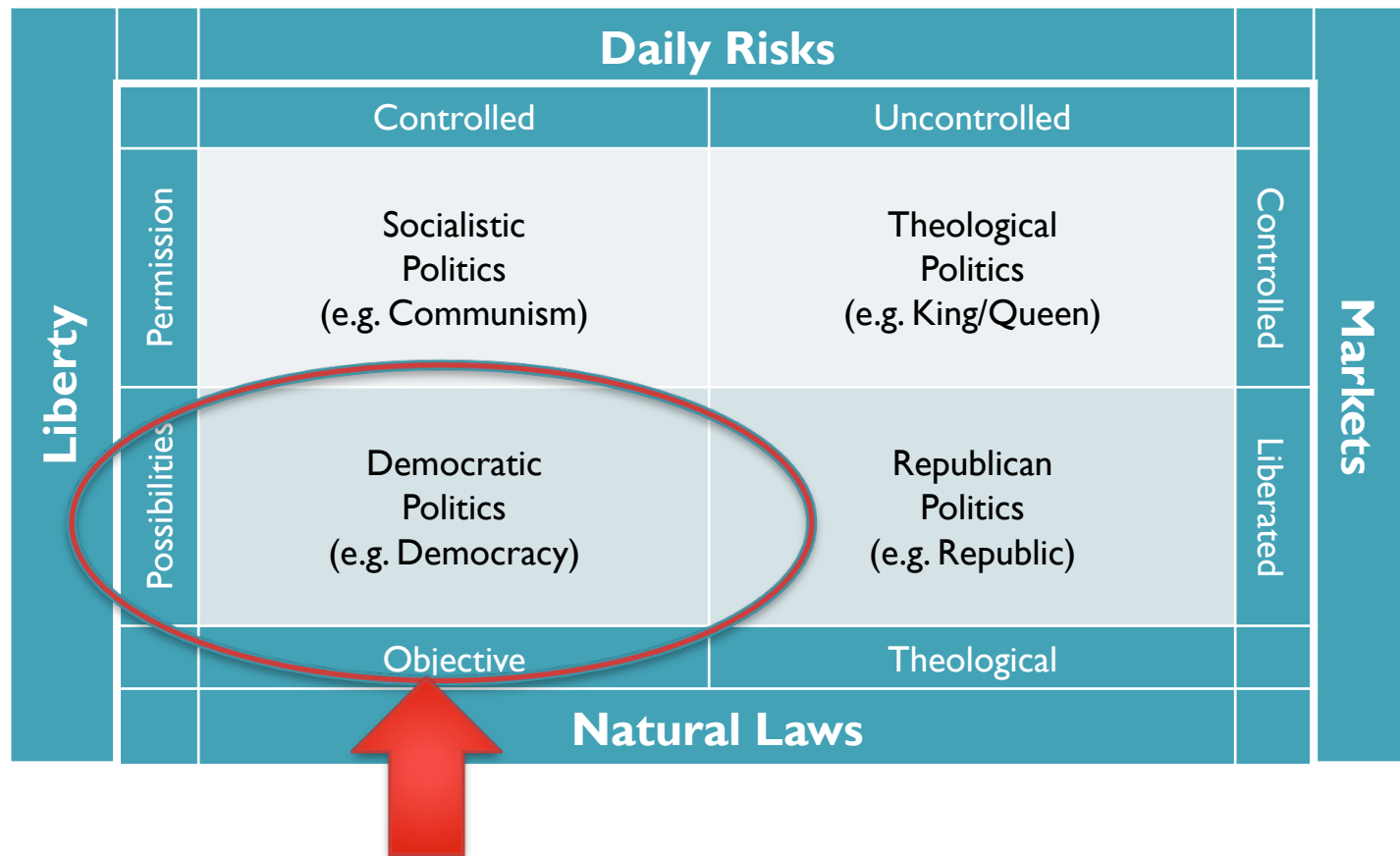

# Realizing the Benefits (Part I)

- If the Republican Political System is the most positive system possible with the least negative impact to the citizens overall, how can we address the forces that are driving us to a new system that focuses on:
  - Money
  - Class Control
  - Win at all Cost
  - Socialism
  - Judicial Justice
  - Dependency
- Within the context of the Republican Political System, the citizenry is unable to separate and differentiate the individuals that represent them. With too many different interests, the population fragments and the group that drives their agenda eventually wins the power.
- A **POLITICAL CERTIFICATION** could focus on some aspects of the spectrum to gain the widest acceptance across the citizens.



# Realizing the Benefits (Part II)

- The Structure Should Address:
  - Money: There must be a mechanism to define a simple system that allows the citizens to financially support their representative of choice.
  - Class Control: There must be a way to monitor the representative once elected in office to temper the desire to gain additional control.
  - Win at all Costs: There must be a way to provide a mechanism to stop the desire to win at all costs.
  - Socialism: There is a need to drive the citizenry to make decisions that rely on independent efforts.
  - Judicial Justice: There is a need to focus on determining what is Justice and what needs to support it.
  - Dependency: There must be a way to communicate and help citizens to choose the path of Independence from the State controlled focus.

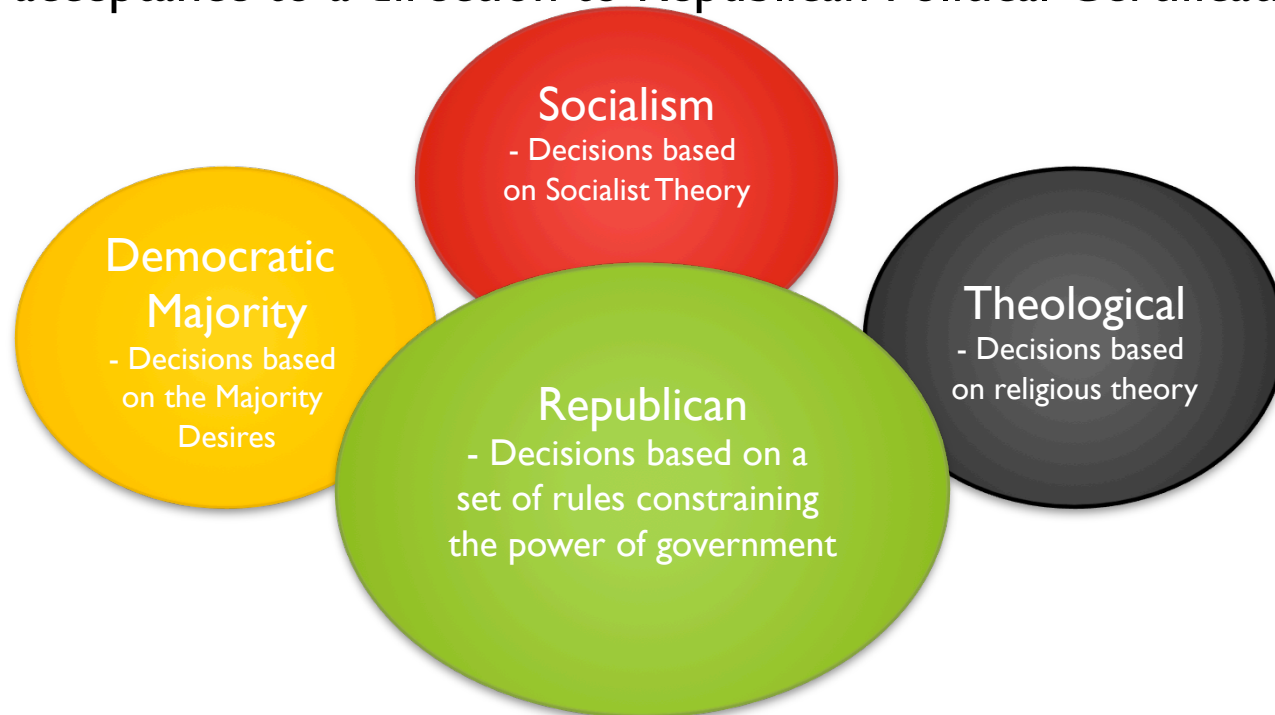


# Realizing the Benefits (Part III)

- Separation of Concepts to Address these 6 areas of focus to best serve all of the Citizenry.
- The Certification should be “Non-Partisan” and not affiliated to a specific party or group. (This allows the group to focus on the principles of the task at hand.)
- In fact, all four political systems could have their own Certification.
  - Republican Political Certification (PRC)
  - Democratic Political Certification (DPC)
  - Socialistic Political Certification (SPC)
  - Theological Political Certification (TPC)
- Since the Founding of the United States was primarily aligned to the Republican Political system, the remainder of this presentation will focus on this potential Certification.

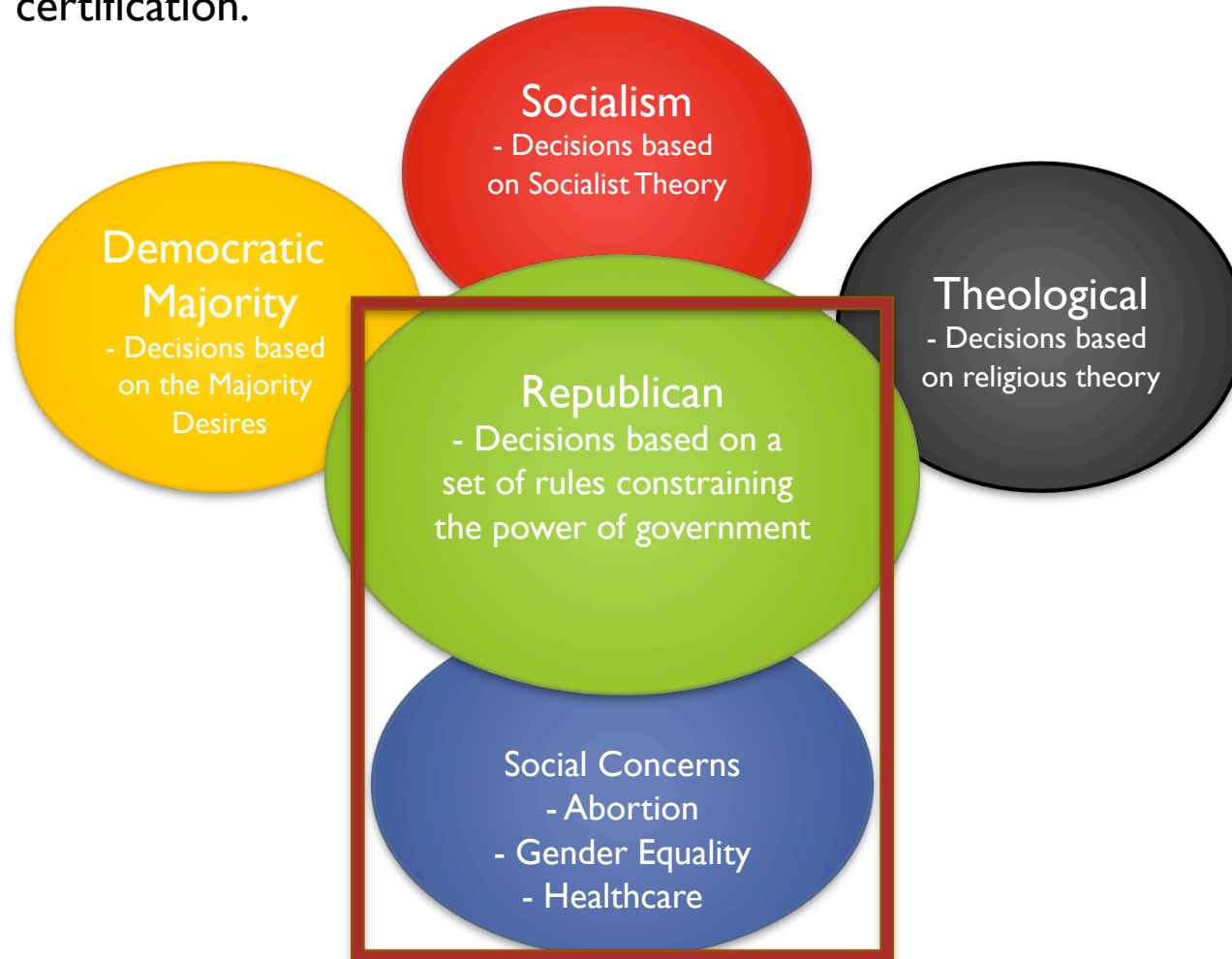
# Realizing the Benefits (Part IV)
