





Persona - Representation of them selves - Their own name


 If the member has a Verified Account then the Persona NFT is automatically approved


Organizational - Any organization that the person represents





















































This Card then shows up in the list of the Main Voting List of the User that Owns this Card for them to complete the Proces for Adding Banking Info and for Network Data.

FD2 Will Provide an API for Partners to user to confirm the existance of a Certified User and to ensure there is a link for payment for that user.

API Method

FD2.certified(Certification Number, 4 Digit Key, User Login ID on FD2, Level, Partner Federalist2.eth ID)

Parameters

Certification Number

The number that was provided when the user completed the certification Test

4 Digit Key

The 4 Digit key that was provdied as the secret key for the User

User ID on FD2

This is the user login ID on Federalist 2.0

Level

This is the level of Certification the user claims to have.

Partner Federalist2.eth ID

The Partner ID given to the Partner by Federalist 2.0 that is a Federalis2.eth ID. This will allow automated payments be given to the Partner based on the Membership Status of the User.

Return

String (0 or Federalist2.eth ID of the User) - Zero is Failure and Federalist2.eth ID of the User is Success NOTE: Providing the Federalist2.eth ID will allow the Partner to Capture the Unique ID of the User for their system, and allow for an end of month reconciliation around payment transactions.

Exceptions

Failure is returned when the following occurs:

- 1) No Certiciation Number Matches
- 2) 4 Digit Key does not match the expected key for the Certification Number
- 3) Certification Number and Related FD2 Login ID do not match
- 4) Certfication Number and Level do not match

These Error codes will be logged on the FD2 Database to be used by Admin to determine next steps.

FD2 Will Provide an API for Partners query for the level of a Federalist 2.0 User.

API Method

FD2.level(User Federalist2.eth ID)

Parameters

User Federalist2.eth ID

This is the Federalist2.eth ID of the User on the Federalist 2.0 (FD2) system, this is the user's unique number.

Return

String (0 or Level) - Zero is Failure and Level the User's level on the Federalist 2.0 Certification (Currently 1 to 6)

NOTE: Providing the Federalist2.eth ID will allow the Partner determine what level the user is at to help know how to filter their content.

Exceptions

Failure is returned when the following occurs:

1) No Federalist2.eth User Exists

Use Case:

This allows the Partner to determine if the User is a ligitimate Certification Holder over time. If or when a users has updated their level, the new level will be communicated at that time. If for some reason the User Opts out of the Certification Program their return value will be Zero.
